ARTICLES OF INCORPORATION

These Articles of Incorporation are signed and acknowledged by the incorporators for the purpose of forming a non-profit corporation under the provisions of Act No. 327 of the Public Acts of 1931, as amended, as follows:

ARTICLE I.

The name of the corporation is EXPERIMENTAL AIRCRAFT ASSOCIATION

ARTICLE II.

The purpose or purposes for which the corporation is formed are as follows:

This corporation is formed for the purposes of promoting the interests of private flying. To promote in the Flint area the designing and constructing of homebuilt aircraft and the restoration of antique aircraft and any other licensed aircraft to safe flying condition, whether on a group or individual basis within the organization.

To engage in and promote educational activities pertaining to designing, constructing, restoration and safe operation of homebuilt, antique and any other licensed aircraft.

To promote safety in all fields of flying whether private or otherwise.

To promote interest of the members in association activities as well as news and activities in the field of flying and to foster and support any and all legislation as may be necessary to carry out the functions and purposes of this organization.
